# Welcome to Shropshire Wildlife Trust

## About the Trust

Shropshire Wildlife Trust is a charity dedicated to caring for the county's wildlife and wild places. Our aims are:

- Conservation of habitats and species native to Shropshire
- Public understanding of and involvement with nature
- Research and recording of wildlife

Our HQ and free entry visitor centre is on Abbey Foregate in Shrewsbury. We also have branches, run by volunteers, in most of the market towns.

## Our members

We have over 10,000 members and it is through their generosity we are able to do our work. We do not receive core funding from central or local government. Our 30 staff are supported by 300 volunteers, massively increasing the amount of work we can do.

## Member information

A welcome pack will be given to you when you join, or sent by post within 2-3 weeks. You will receive a membership card that is renewed annually. We produce a members' magazine *Shropshire Wildlife* three times per year. This has both local stories and articles of national interest. We may occasionally contact you directly to invite you to an event, or seek your support for a campaign or appeal. We will not share your details with any other organisation, or use them irresponsibly.

## Direct Debit

If you are a monthly payer the payments will be taken from your account on the 1<sup>st</sup> of each month. Annual payers will be debited on the anniversary of your join date. Direct Debits are in your control and can be altered at any time to suit your circumstances.

## Gift aid

If you are a UK tax payer please sign the gift aid declaration. This means that we can reclaim tax from your membership and any subsequent donations – at no additional cost to you.

## The Direct Debit Guarantee

If you request Shropshire Wildlife Trust to collect a payment, confirmation of the amount and date will be given to you at the time of the request

If an error is made in the payment of your Direct Debit by Shropshire Wildlife Trust or your bank or building society you are entitled to a full and immediate refund of the amount paid from your bank or building society. If you receive a refund you are not entitled to, you must pay it back when Shropshire Wildlife Trust asks you to
